| <p><b>1. <u>Constitution</u></b></p> <p>1.1 The Committee is established pursuant to a resolution passed by the Board at its meeting held on 6 September 2016.</p>  | <p><b>組成</b></p> <p>本委員會是按本公司董事會於 2016 年 9 月 6 日會議通過成立的。</p>   |
| <p><b>2. <u>Membership</u></b></p> <p>2.1 Members of the Committee shall be appointed by the Board from amongst the non-executive directors of the Company only and shall consist of not less than three members, a majority of whom should be independent non-executive directors. At least one member is an independent non-executive director with appropriate professional qualifications or accounting or related financial management expertise as required in Rule 3.10(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "<b>Listing Rules</b>").</p> <p>2.2 The chairman of the Committee shall be appointed by the Board and shall be an independent non-executive director.</p> <p>2.3 A former partner of the Company's existing auditing firm shall be prohibited from acting as a member of the Committee for a period of two years from the date of his/her ceasing (a) to be a partner of the firm; or (b) to have any financial interest in the firm, whichever is the later.</p> <p>2.4 The company secretary of the Company shall be the secretary of the Committee.</p> <p>2.5 The appointment of the members or secretary of the Committee may be revoked, or additional members may be appointed to the Committee by separate resolutions passed by the Board and by the Committee.</p> | <p><b>成員</b></p> <p>委員會由董事會從其非執行董事中委任組成，委員會人數最少三名，大部分之成員應為獨立非執行董事，其中至少一名須按照香港聯合交易所有限公司證券上市規則("上市規則")第 3.10(2)條具備適當專業資格或會計或相關財務管理知識。</p> <p>委員會主席由董事會委任及必須是獨立非執行董事。</p> <p>現時負責審計本公司賬目的核數公司的前任合伙人在以下日期（以日期較後者為準）起計兩年內，不得擔任委員會成員：(a)他／她終止成為該核數公司合伙人的日期；或(b)他／她不再享有該核數公司賬務利益的日期。</p> <p>本公司的公司秘書為委員會的秘書。</p> <p>經董事會及委員會分別通過決議，方可委任額外的委員會的成員或罷免委員會的成員或秘書。</p> |

### 3. Proceedings of the Committee

#### 3.1 *Notice:*

- (a) Unless otherwise agreed by all the Committee members (either orally or in writing), a meeting shall be called by giving at least seven days' notice.
- (b) A Committee member may and, on the request of a Committee member, the secretary to the Committee shall, at any time summon a Committee meeting. Notice shall be given to each Committee member in person orally or in writing or by telephone or by email or by facsimile transmission at the telephone or facsimile or address or email address from time to time notified to the secretary by such Committee member or in such other manner as the Committee members may from time to time determine.
- (c) Any notice given orally shall be confirmed in writing as soon as practicable and before the meeting.
- (d) Notice of meeting (or notice of confirmation of meeting) shall state the purpose, time and place of the meeting and shall be accompanied by an agenda together with other documents which may be required to be considered by the members of the Committee for the purposes of the meeting. In respect of regular meetings of the Committee to be held as mentioned in clause 3.4 below, and so far as practicable for all other meetings of the Committee, the agenda and accompanying papers shall be sent in full to all the members of the Committee in a timely manner and at least 3 days before the intended date of the meeting of the Committee (or such other period as all the Committee members may agree).

3.2 ***Quorum:*** The quorum of the Committee meeting shall be two members of the Committee.

3.3 ***Attendance:*** The finance director, the head of internal audit (or any officer(s) assuming the relevant functions but having a different designation) and a representative of the external auditors shall normally attend meetings. Other Board members shall also have the right of attendance. However, at least twice a year the Committee shall meet with the external auditors without executive Board members present.

### 會議程序

#### 會議通知:

- (a) 除非委員會全體成員同意(口頭或書面)，委員會的會議通知期，不應少於七天。
- (b) 任何委員會成員或委員會秘書(應委員會成員的請求時)可於任何時候召集委員會會議。召開會議通告必須親身以口頭或以書面形式、或以電話、電子郵件、傳真或其他委員會成員不時議定的方式發出予各委員會成員不時通知秘書的電話或傳真號碼或電郵地址或郵寄地址。
- (c) 以口頭通知方式召開的會議，應儘快及在會議召開前以書面方式確實。
- (d) 召開會議的通告(或確認會議通告的函件)必須說明開會目的、開會時間、地點、議程及連同有關文件予各成員參閱作為開會之用。第 3.4 條所述委員會定期會議的議程及有關文件應全部及時送交委員會全體成員，並至少在計劃舉行委員會會議日期的最少三天前(或委員會全體成員協定的其他時間內)送出。委員會其他所有會議在切實可行的情況下亦應採納以上安排。

***法定人數:*** 委員會會議法定人數為兩位成員。

***出席:*** 主管財務的董事，公司內部核數的主管(或任何主管承擔類似工作，但被指定為不同職稱)及一位外聘核數師的代表通常應出席會議。其他董事會的成員亦有權出席會議。無論如何，委員會應至少每年兩次在沒有執行董事出席的情況下，會見外聘核數師。

3.4 **Frequency:** Meetings shall be held at least twice annually, or more frequently if circumstances require and with unanimous written consent to consider the budget, revised budget and, if published for publication, quarterly report prepared by the Board. The external auditors may request the chairman of the Committee to convene a meeting, if they consider that one is necessary.

#### 4. Written resolutions

4.1 Written resolutions may be passed by all Committee members in writing and signed by all Committee members.

#### 5. Alternate Committee members

A Committee member may not appoint any alternate.

#### 6. Authority of the Audit Committee

6.1 The Committee may exercise the following powers:

- (a) to seek any information it requires from any employee of the Company and its subsidiaries (together, the “**Group**”) and any professional advisers (including auditors), to require any of them to prepare and submit reports and to attend Committee meetings and to supply information and address the questions raised by the Committee;
- (b) to monitor whether the Group’s management has, in the performance of their duties, infringed any policies set by the Board or any applicable law, regulation and code (including the Listing Rules and other rules and regulations from time to time determined by the Board or a committee thereof);
- (c) to investigate any activity within these terms of reference and all suspected fraudulent acts involving the Group and request the management to make investigation and submit reports;
- (d) to review the Group’s risk management and internal control procedures and systems;
- (e) to review the performance of the Group’s employees in the accounting and internal audit department;

**開會次數:** 每年最少開會兩次或(若有所需及有一致書面同意時)多於兩次, 討論董事會提呈的預算、修訂預算及(若發行公布)季度報告草稿。如外聘核數師認為需要, 可要求委員會主席召開會議。

#### 書面決議

委員會成員可以以書面贊成方式通過任何決議, 惟有關書面決議必須由所有委員會成員簽字。

#### 委任代表

委員會成員不能委任代表。

#### 審計委員會的權力

委員會可以行使以下權力:

- (a) 要求本公司及其任何附屬公司(統稱為“**本集團**”)的任何雇員及專業顧問(包括核數師)準備及提交報告及出席委員會會議提供所需資料及解答委員會提出之問題;
- (b) 監控本集團管理人員在履行職務時有否違反董事會訂下的政策或適用的法律、法規及守則(包括上市規則及董事會或其委員會訂立的規則);
- (c) 調查本職權範圍中的任何活動及所有涉及本集團的懷疑欺詐行為及要求管理層就此等事件作出調查及提呈報告;
- (d) 評審本集團風險管理及內部監管措施及系統;
- (e) 評審本集團的會計及內部核數部門雇員的表現;

## 7. Duties

7.1 The duties of the Committee shall be:

### *Relationship with the Company's auditors*

- (a) to be primarily responsible for making recommendation to the Board on the appointment, re-appointment and removal of the external auditor, and to approve the remuneration and terms of engagement of the external auditor, and any questions of its resignation or dismissal;
- (b) to review and monitor the external auditor's independence and objectivity and the effectiveness of the audit process in accordance with applicable standards;
- (c) to discuss with the auditors the nature and scope of the audit and reporting obligations before the audit commences;
- (d) to develop and implement policy on engaging of an external auditor to supply non-audit services. For this purpose, "external auditor" includes any entity that is under common control, ownership or management with the audit firm or any entity that a reasonable and informed third party knowing all relevant information would reasonably conclude to be part of the audit firm nationally or internationally. The Committee should report to the Board, identifying and making recommendations on any matters where action or improvement is needed;

### *Review of the Company's financial information*

- (e) to monitor the integrity of the Company's financial statements and annual report and accounts, half-year report and, if prepared for publication, quarterly reports, and to review significant financial reporting judgements contained in them;
- (f) in reviewing these reports mentioned in paragraph (e) before submission to the Board, focusing particularly on:
  - (i) any changes in accounting policies and practices;

## 審計委員會的責任

委員會負責履行以下責任：

### *與本公司核數師的關係*

- (a) 主要負責就外聘核數師的委任、重新委任及罷免向董事會提供建議，批准外聘核數師的薪酬及聘用條款、及處理任何有關該核數師辭職或辭退該核數師的問題；
- (b) 按適用的標準檢討及監察外聘核數師是否獨立客觀及核數程序是否有效；
- (c) 於核數工作開始前先與核數師討論核數性質及範疇及有關申報責任；
- (d) 就外聘核數師提供非核數服務制定政策，並予以執行。就此規定而言，“外聘核數師”包括與負責核數的公司處於同一控制權、所有權或管理權之下的任何機構，或一個合理知悉所有有關資料的第三方，在合理情況下會斷定該機構屬於該負責核數的公司的本土或國際業務的一部份的任何機構。委員會應就任何須採取行動或改善的事項向董事會報告並提出建議；

### *審閱本公司的財務資料*

- (e) 監察本公司的財務報表以及年度報告及賬目、半年度報告及(若擬刊發)季度報告的完整性，並審閱報表及報告所載有關財務申報的重大意見；
- (f) 在向董事會提交上述第(e)段有關報表及報告前，應特別針對下列事項加以審閱：
  - (i) 會計政策及實務的任何更改；

## **10. Powers of the Board**

- 10.1 The Board may, subject to compliance with the articles of association of the Company and the Listing Rules (including the Corporate Governance Code and Corporate Governance Report set out in Appendix 14 to the Listing Rules or if adopted by the Company, the Company's own code of corporate governance practices), amend, supplement and revoke these terms of reference and any resolution passed by the Committee provided that no amendments to and revocation of these terms of reference and the resolutions passed by the Committee shall invalidate any prior act and resolution of the Committee which would have been valid if such terms of reference or resolution had not been amended or revoked.

## **董事會權力**

本職權範圍所有規則及委員會通過的決議，可以由董事會在不違反公司章程及上市規則的前提下(包括上市規則之附錄十四《企業管治守則》及《企業管治報告》或公司自行制定的企業管治常規守則(如被採用))，隨時修訂、補充及廢除，惟有關修訂、補充及廢除，並不影響任何在有關行動作出前，委員會已經通過的決議或已採取的行動的有效性。
